Currently, San Francisco remains at Level 3 Moderate Alert with 4.3 new cases daily per 100,000 population (Goal 1.8 per 100,000). This is equal to about 37 new cases daily in San Francisco. More San Francisco COVID19 public health indicators are available via this <u>SFDPH Website</u>.

NEW: COVID-19 Emergency Paid Sick Leave available to employees in 2021

UC recently announced that all University paid employees will have available, for immediate use, a new allotment of Emergency Paid Sick Leave (EPSL). Key highlights include:

- This ESPL is new, separate from COVID Paid Administrative Leave (PAL).
- Full time employees may take up to 80 hours of EPSL; part-time employees will be allocated a two-week equivalent.
- All employees are eligible to use EPSL if they meet 1 or more of the qualifying COVID-related reasons.
- All employees are eligible to use EPSL for COVID-impacted childcare-related reasons, including health care workers.
- Employees should contact their supervisor/manager or submit this <u>form</u> in order to use this time.

UCSF Inpatient COVID Vaccination for eligible patients starts April 8th

UCSF is expanding COVID vaccination to eligible inpatient populations starting **Thursday April 8th at Parnassus, Mission Bay and Mount Zion campuses.** Highlights include:

- Eligible patients:
 - 1. All patients 65 years and older OR
 - 2. Patients 18 years and older who are planned for discharge to congregate settings (Skilled Nursing Facilities, Long Term Care Facilities, etc.)
- Janssen (Johnson & Johnson) single-dose vaccine only
- Weekday administration only (Monday Friday)
- Orders placed Monday Thursday will be batched and delivered for administration by 12 noon the NEXT DAY; orders placed Friday Sunday will be delivered for administration the following Monday.

Patients that fall outside the above eligibility criteria but who are eligible for vaccination according to California eligibility criteria will obtain their vaccines in the outpatient setting after discharge.

Workflows: The new <u>"COVID-19 Vaccine Screening Panel"</u> will appear automatically at admission for all patients 65 years and older. It can also be manually ordered in case deferred on admission or for planned congregate setting discharges. Please <u>refer here</u> for details of the ordering workflow. Details of the administration workflow for nursing can be found here: <u>Nursing workflow</u>. **The goal is to vaccinate patients as soon as clinically stable, early during their hospitalization**.
